### **TxDMV Updates**

### New Position to Support Senate Bill 224 Implementation

Senate Bill 224, passed during the 88th Legislative Session, amends Occupations Code, Chapter 2305, by providing additional requirements for certain, regulated entities that buy and sell catalytic converters. The Vehicle Titles and Registration (VTR) Division will use allocated funding for a new position. To facilitate the new record keeping requirements, the department plans to automate reporting with programming changes to webSALVAGE. This information will then be made available to the respective regulating entities for any enforcement efforts. The new VTR position will be dedicated to developing business requirements for necessary programming changes and title policy and procedure efforts relative to theft prevention activities. The new employee will serve as a liaison between VTR and the Motor Vehicle Crime Prevention Authority for such initiatives.



#### Warehousing and Distribution Request for Proposal (RFP)

House Bill 718 eliminates temporary paper tags and replaces them with metal plates for their customers and their own business use. To ensure dealers and buyers have the plates needed, metal license plates will need to be distributed to individual dealerships statewide. This change will require a fundamental overhaul of the current distribution model.

In Fiscal Year 2023, approximately 5.4 million license plates were distributed to county tax office and TxDMV Regional Service Center (RSC) locations. Currently, a Texas Department of Criminal Justice warehouse in Huntsville distributes plates to county tax offices and RSCs. The plates are then issued to dealers and the public. The Motor Vehicle Division also distributes dealer license plates to individual dealerships via the U.S. Postal Service.

Our License Plate Design and Manufacturing Committee considered multiple options for distribution while considering risk, efficiency, and stakeholder benefit. The committee determined that shipping license plates directly to dealers, instead of routing them through county tax offices, is the preferred method. A third-party warehouse and order fulfillment vendor is currently being selected under a competitive procurement process.

### webDEALER Training Initiative

VTR's webDEALER training efforts continue for dealers and counties across the state.

Lori Stovall, Jessica Jimenez, and Paige Noble conducted webDEALER training at the Tax Assessor-Collectors Association (TACA) conference on June 4 in Dallas. There were approximately 150 Tax Assessor-Collector staff in attendance.

The Legislative Services Department hosted four Legislative Exchange meetings earlier this year in Cameron, El Paso, Jefferson and Yoakum Counties providing an opportunity for county officials and staff to candidly discuss legislative issues with our team. We are planning to host four additional exchanges later this year which will be announced on the TAC website and through our newsletters once the locations and dates are established.

Additionally, we continue to monitor the Texas Department of Motor Vehicles (TxDMV) rulemaking process related to implementation efforts for legislation passed last session transitioning from temporary paper plates to metal plates and eliminating the safety inspection requirements for vehicles in 2025. As it relates to the elimination of temporary paper plates, the rules proposed at the TxDMV Board meeting June 27, 2024 outlined a process in which TxDMV will deliver plates directly to dealers, thereby not requiring counties to consider secure distribution options for dealers picking up plates at county offices. The TxDMV Board is currently accepting comments and plans adopt the rules at their October 2024 meeting.

Lastly, registration remains open for TAC's 2024 Legislative Conference, happening Aug. 28-30 in Austin. In addition to some great networking events, the conference agenda includes sessions covering Truth-in-Taxation updates and how to handle First Amendment Audits. ### **Boat Titling & Registration**

### **Program Training**

The Texas Parks and Wildlife Department (TPWD) Boat Titling, Registration and Marine Licensing section offers online training covering a variety of program related topics. This training is open to all processing staff, from the beginner to those with more experience, and both counties who participate with our program, as well as those who do not.

To sign up and attend the training participants must have:

- Access to a computer with internet access.
- An email address to receive the class invitation and any associated training material.
- Speakers or headphones to be able to listen to the audio portion of the presentation.
- \* A microphone is helpful during question-and-answer sections but is not required to attend.

The BRITS core class is an introductory class covering the core program basics, including available resource materials, the most common forms used, basic transaction processing in the Boat Registration Information and Titling System (BRITS), common reports, document packaging, and more. This class is four (4) hours in length, typically divided into two, two-hour sessions (typically with the first held in the morning, and the second half held in the afternoon on the same day).

Other classes vary in length depending on the topic being covered, usually taking 30 minutes to one hour. Additional training topics include:

- Decal Inventory Procedures
- Fee Overrides, Processor Errors & Voids
- Non-Standard Titles (Skip, Bond, Abandoned)
- Statutory Lien Foreclosures

- Document Packaging
- Forms
- Post Transaction Audit Compliance
- Temporary Tax Permits

### New Boat Registration & Titling System

A new Boat Titling & Registration system (BTR) is under internal development by TPWD. Designed to be a web-based application, it will provide greater flexibility to plan and execute future changes and updates. While the look and feel will be different, incorporating a modern UI/UX design, basic system functionality will remain the same.

At the recent TACA conference in June, several participating counties volunteered to provide intermittent testing assistance as the system is developed. We appreciate the opportunity to work with our partners and system stakeholders on this project.

Implementation of the new system is currently planned for January of 2026, with training expected to being in the Fall of 2025.
