TxDMV Update

Legislative Update

The Texas Department of Motor Vehicles continues to process legislative requests impacting the department, including bill analyses, fiscal notes, cost estimates, and hearing preparations. As of early May, the Vehicle Titles and Registration (VTR) Division has reviewed 101 bills covering topics such as autonomous vehicles, miniature vehicle registration, new specialty license plates, and the implementation of a real-time county scofflaw reporting system. The regular legislative session concludes on June 2, 2025.

webDEALER Training

Ahead of the April 30, 2025, mandatory dealer training deadline, VTR conducted nine in-person training events and six live webinars in April. Locations included Bexar, Ellis, Harris (twice), Webb, Hidalgo, and Tarrant counties, plus two Texas Independent Automobile Dealers Association (TIADA) events. Since February 2024, 143 training sessions have taken place, with 20,481 attendees and 11,229 licensed General Distinguishing Numbers (GDNs) trained.

During the roundtable discussion, participants focused heavily on HB718 and its implications for dealers moving forward. The newly elected TACs contributed thoughtful questions and helped generate engaging discussion.

There is also a very handy Dealer reference brochure you can print for your Dealers and a FAQ's About Dealer Plates.

BUYER PROVISIONAL BYR1BBBBB	Buyer Provisional Plate	For short-term use if dealers lack the required plate type for the vehicle in their inventory.
TEXAS DLR1BBBB - LANCE MERCAN	Dealer Temporary Plate	For dealers' business-related uses, such as test drives, loaner vehicles, or transporting the vehicle. Personal use of vehicles with these plates is prohibited. The new Dealer Temporarily Plate does not replace the current metal dealer license plate, which is permissible for dealers' personal use.
STEXAS OSB1BBBB	Out-of-State Buyer Plate	For vehicles sold to out-of-state buyers.
	Temporary Registration Plate	For temporary registration, replacing one-trip and 30-day permits (issued by county tax offices and TxDMV regional service centers).
