- I. Call to Order – Randy Riggs called the business meeting to order at 9:00 AM
- II. Prayer and Pledges – Kevin Kieschnick led the attendees in prayer. Pledges were not performed citing the absence of the US and Texas flags
- III. Official Count of Tax Assessor/Collectors – Sergeants at Arms Justin Coryell and Gary Barber performed the count of members. It was determined that there were 138 members present.
- IV. Presentation of Year-End Financials – Larry Gaddes presented documents to the membership that included a year-end Statement of Activity summarizing the revenue and expense activity of the association, year-end detail of transactions by line item, and the FY2022-2023 approved budget. An explanation was provided for the timing of the beginning/end of the fiscal year.
- V. Election of Board of Directors – Mary Ann Waters and members of the Elections Committee conducted the election of board members. After presiding as President-Elect, Bruce Stidham was declared president. Nominees for each position were presented as: President-Elect – Kevin Kieschnick and Shay Luedeke, Vice President – Donna Willis, Secretary – Wendy Burgess and Allison Getz, Treasurer – Larry Gaddes, Directors – Monica Foster, Ruben Gonzalez, Karen Lane, and Dawn Vieth. Shay Luedeke withdrew his nomination for President-Elect. The vote was unanimous to declare Kevin Kieschnick President-Elect. The vote was unanimous to declare Donna Willis Vice President. Allison Getz won the majority of votes for Secretary. The vote was unanimous to declare Larry Gaddes Treasurer. From the floor, Monty Shaw nominated Wendy Burgess for Director. Ruben Gonzalez and Dawn Vieth were declared winners to fill 2 open positions for Director.
- VI. Committee, Liaison, and Representative Reports – John Ames presented resolutions for 3 honorary members recommended by the Honorary Membership Committee and approved by the Board at a previous meeting. Those receiving the honor are Connie Rose, Dennis Hart, and Caroline Love. Teresa Garth moved as vice-chair of the resolutions committee and John Ames seconded the resolutions committing the honorary membership. The vote was unanimous.
